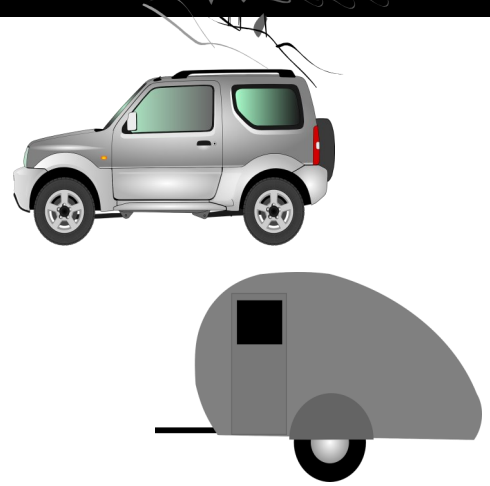

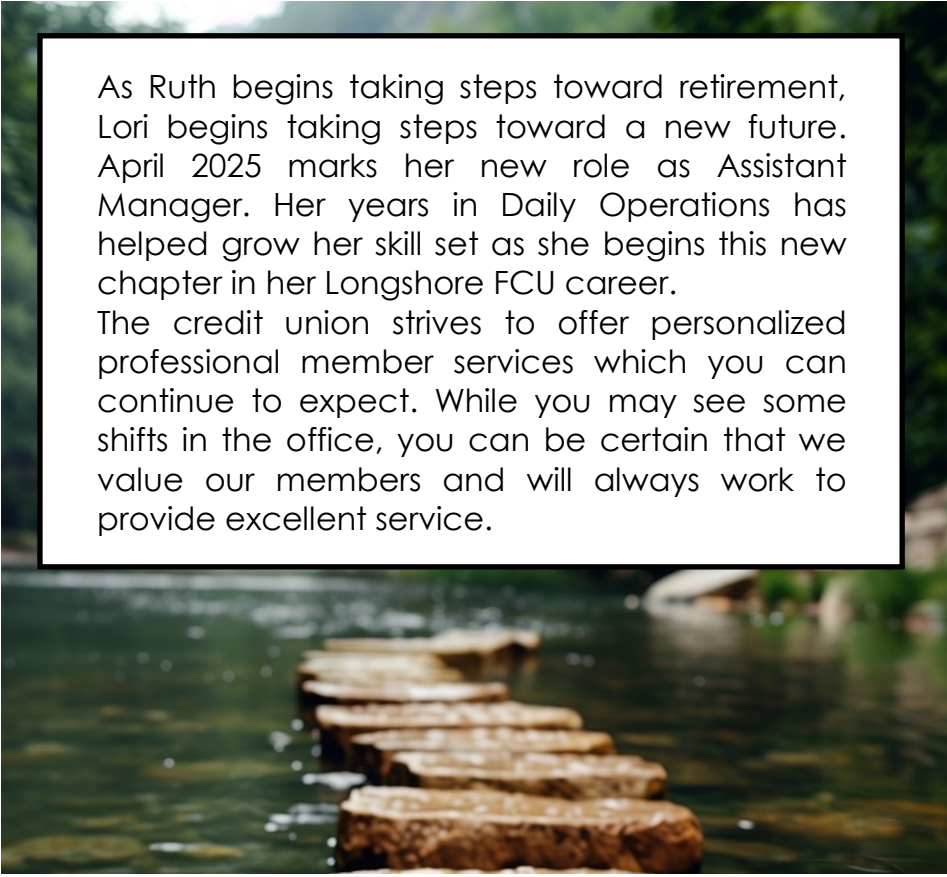

Complete a loan application, provide recent verification of income along with the \$10.00 application fee. All loans are granted on approved credit.

# Something To Know About Your Debit Card



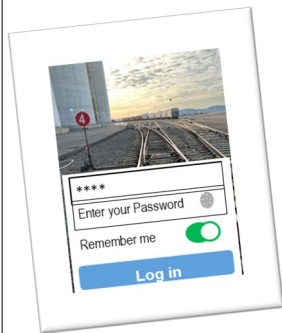
Some transactions may trigger a temporary block on your debit card. Maybe you're shopping at a new place, on a new website or in a new area. Our card processing fraud department is alert and until the questionable transaction is verified, a block on your card may interrupt its function.

Our fraud team will call the number on file for the card holder to confirm transactions. If purchases are valid, they will release the block and the card will be ready to use. If the transactions are fraudulent, a permanent block will be placed and a new card will need to be ordered. Our card processing fraud team will not email or text you. They will ask reasonable questions to verify your identity. Never give out your entire card number with its expiration date and CVV code to anyone calling you. Never give out your social security number to anyone calling you. Our fraud team works hard to protect your account against scams and fraudulent activity. If you have any questions about our card department, please call us at the credit union.

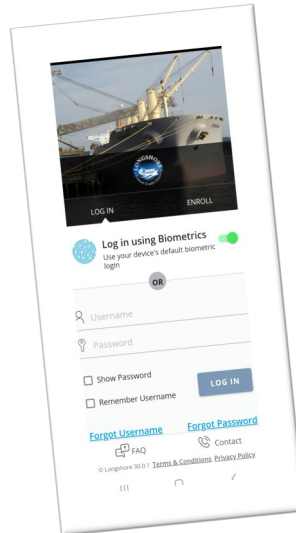
